This charge is subject to change based on any increases in dues by HRRRA, VAR or NAR during this period. (*\*Per policy, HRRRA dues increase annually by CPI.*)

Please add an additional \$5 (\$23 for brokers, \$10 for managing brokers) to each of the twelve scheduled payments above for contributions to HRRPAC, RIM and the HRRRA Foundation. These contributions are non-refundable. (*initials: \_\_\_\_\_*)

Contributions to HRRPAC are not deductible for Federal income tax purposes. Contributions to HRRPAC are voluntary and are used for political purposes. The amount indicated is merely a guideline and you may contribute more or less than the suggested amount. The Association will not favor or disadvantage anyone by reason of the amount of their contribution, and you may refuse to contribute without reprisal by the Association. 40% of each contribution is used by HRRPAC.
